Volume 12, Number 2, was published online in March 2020. Articles offer a historical and dynamic panorama of Hungarian law, with Professor Emeritus Attila Harmathy as a guide (Tucker Lecture 2018). You will explore the #MeToo movement and its legal implications in France and the U.S. with Anne Wagner and Sarah Marusek. This issue also includes a note on the Louisiana Digest of 1808, and discusses Brexit matters under the angle of a largely unknown Scottish institution. Substantial book reviews and case notes conclude the volume.

The Editors call the readers' attention to the remarkable LSU student contribution to our Civil Law in Louisiana feature, with six case notes prepared by students under faculty supervision. This is meant to serve the Louisiana legal community while showcasing Louisiana jurisprudence, making it more visible to the world.

Sabbatical Semester, Spring 2020



During his sabbatical semester, Professor Moréteau honoured three invitations. In February 2020, he was a visiting professor at Université Jean Moulin Lyon 3, his alma matter, where he taught Louisiana Law in a North American and Global Perspective (12 hours) at the Institut de droit compare Édouard Lambert, and gave two lectures, also attending meetings and conferences and negotiating a double degree that would pair Lyon’s Master in Private International and Comparative Law with LSU’s LL.M. in Comparative Law. In March, he was a visiting professor at Aix-Marseille Université, Aix-en-Provence, where he taught U.S. Contract Law (12 hours) and gave three lectures.

A guest lecturer at Université Paris 1 Panthéon-Sorbonne for three weeks starting March 16, he is confined in Lyon due to the Covid-19 pandemic and teaches Comparative Contract Law remotely, in the Master’s degree in English and North American Business Law.
